Compression Planning®: 40 Years of Getting to Better Decisions Faster

Compression Planning® was developed by McNellis & Associates in 1978. Combining best practices created by Leonardo da Vinci and the Walt Disney Corporation, the seven-step process compresses the time needed to develop effective project plans.

Current Enforcement Environment for Federal Grantees

In recent years, there has been a significant increase in scrutiny of Federal grants and grantees by agency Offices of Inspectors General and the Department of Justice in an attempt to ensure compliance with grant terms and conditions, as well as combat fraud, waste and abuse. Cybersecurity for Grants

The Uniform Guidance places responsibility on grantors and grantees to protect data of recipients and others. The ability to recover from advanced threats is a critical component to a comprehensive cybersecurity program.

All applications, forms, reports, and surveys Federal agencies use are subject to the Paperwork Reduction Act (PRA). This means that PRA must be taken into consideration when grant programs seek to make changes to applications or compliance reports. Pre-award and the Reduction of Applicant Financial Risk

2 CFR 200.205 "Federal Awarding Agency Review of Risk Posed by Applicants" requires each HHS OPDIV to develop a process for conducting pre-award risk assessments to determine the risk an applicant poses to meeting federal programmatic and administrative requirements by taking into account financial instability, among other factors. This session will cover how HRSA identifies and mitigates pre award financial risk and the effects on an entity's grant application.

Sub-recipient Non-compliance, is Your Monitoring Program Strong Enough?

We are all doing more with less these days and it seems monitoring takes a back-seat to other critical grants management tasks. However, it is often overlooked the risk that agencies are taking when not developing a comprehensive monitoring program or completing monitoring reviews late in the grants process. Just because a sub-recipient agency is strong in meeting their program specific goals, does not mean they are properly administering the funds in accordance with requirements. This presentation will provide case study examples from audits from the US Department of Homeland Security, Office of Inspector General over two federal programs in Ohio that had significant questioned costs because of sub-recipient non-compliance. How sub-recipient monitoring efforts could have prevented or detected these issues will be discussed, as well as, provide agencies with some ideas on how to strengthen their current monitoring programs.

The False Claims Act and You

The civil False Claims Act (31 U.S.C. §§ 3729 – 3733) is one of the Federal government’s most potent anti-fraud tools. Its most commonly used provision prohibits “knowingly” presenting false claims to the government and violations are subject to treble damages plus penalties. Grant funded program leadership must be aware of this law, the common ways it impacts programs, and most importantly, the best ways to avoid these issues.

Understanding Cost Sharing
